TAX INVOICES

All tax invoices for property, water and personal taxes were mailed out the week of January 7th. Business taxes will follow shortly.

All residents with a prior balance are to note that accounts are in the process of being transferred to collections (if you have not been making regular monthly payments). Please ensure that your account is up to date to prevent further action from taking place.

Tax collection for the town for the 2003 taxation year finished at 92.96% - down from last year by a little over a quarter of a per cent (93.25%). This was extremely disappointing as this is the first year since 1999 that the tax collection percentage has been down at all. Residents are reminded that tax collection is the life-blood of the town - it take your tax dollars to keep this town operating. In all, the town is still owed \$25,342.73 for 2003 and prior!!

We hope this year will be better! Please help us make it better - we all have to do our part.

NEW TOWN TRUCK

Council is quite pleased to inform residents that through the financial assistance of our provincial government have managed to acquire a new 2004 Chev ¹/₂ ton pick-up. The main objective of this vehicle is for animal control however it will also be used for garbage collection and various other small jobs around town. The original sale price of the truck was \$33,057.60. All council had to pay was \$7373.58 (or 20% of the total price). Council have taken out a two year loan to paid the \$7373.58.

The truck came with a cap, new winter tires and a trailer hitch. It also had the town logos on the doors. NOTE: Council invoiced over \$22,000.00 for animal control in 2003 - the funds that council now owes on the new truck will come from these funds.
