TAX COLLECTION

As of February 9th, 2010, the town's collection rate for 2010 stands at 95.84%. Compared with the same time last year, the town's collection rate is up from 95.26%

Council would like to sincerely thank residents who have been diligent with the payment of their account and would like to remind everyone that January 31st was the last day for the 5% discount and February 28th is the last discount date for current year's taxes.

To those residents in arrears and not honoring agreements, please note that further action is being taken!



There is still a discount available for February. If your account is paid in full by February 28th you are entitled to a 3% discount.

NOTE: All seniors (65 years of age or older - or turning 65 any time during 2010) are eligible for an additional 5% discount.

The town of Reidville would like to inform residents that a letter has been received from the Department of Environment & Conservation concerning the burning of certain materials. They wanted people to know that it is prohibited to burn tires, plastics, treated lumber, asphalt and asphalt products, drywall, demolition waste, hazardous waste, biomedical waste, trash, garbage, or other waste from commercial, industrial or municipal operations, manure, rubber, tar paper, railway ties, paint and paint products, fuel and lubricant containers, used oil, animal cadavers, hazardous substances, and materials disposed of as part of the removal or decontamination of equipment, buildings or other structures.
