RABIES...

As most residents are aware, Rabies has been noted in the St. Paul's and White Bay areas. Residents are asked to note any unusual behaviour from their pet(s). According to Dr. Minnie Wasmeier, any incidents of strange animal behaviour must be reported to a wildlife or a police officer or to Health and Community Services Western. It is important to include as much detail as possible including:

- *date of incident
- * type of animal
- * details in the incident
- * behaviour of animal and any variation in behaviour
- * immunization history for rabies (for domestic animals)
- * possible contacts of animal (animal or human)
- * location of animal
- * whether animal is restrained or still at large
- * owner of animal (if domestic), and owners of any animals bitten.

Any person who has been bitten by or in contact with a possible rabid animal must seek medical attention. The best first aid treatment includes thorough and immediate cleaning of the wound with soap and water.

SNOW

NOTE: It is illegal to dump snow onto a public roadway.

As was printed in prior newsletters, residents are reminded that parking on the sides of roads in the town is not permitted. Violators will be ticketed by the RCMP.

- *Repairing lockers for firemen in Fire Hall
- *Keeping fire hydrants clear of snow
- *upgrading (painting) stairs in Fire Hall
- *Installing new doors in certain areas of community hall
- *creating storage area in community hall
- *building signs for certain areas of town
- *building sports bin for softball equipment
- *building recycling bin for outside of community hall and other small jobs as required.
