The cost of all Permits have increased to the following:

Commercial: \$200.00
per building
New House: \$100.00
House Extension: \$50.00
Accessary Buildings: \$25.00
General Repairs: \$10.00

There is No Charge for a General Repairs permit for Seniors.

Please Note: All taxes for prior years must be paid in full before a permit will be issued.

TAX COLLECTION

As of Tuesday, March 11th, the town's collection rate for the current year (2008) stands at 66.17%. Compared with the same time last year, the town's collection rate is up from 64.57%

Council would like to sincerely thank residents who have been diligent with the payment of their account.

To those residents in arrears and not honoring agreements, please note that plans are



underway to proceed with further action. The town is in the process of auctioning off arrears accounts again to ensure that collections remain up to date. Also water disconnection

notices will be delivered in the coming weeks.
