# **PRECAUTIONARY BOIL ORDER**

The town has recently begun installation of five new fire hydrants. 1. Operate or permit operation of unregistered vehicle

- 2. Operating vehicle without places
- 3. Operating vehicle on a roadway
- 4. Operating vehicle without driver's license
- 5. Operating vehicle without insurance

6. Operating vehicle without due care and attention

7. Operate or permit operation of ATV under the age of 16

- 8. Operating ATV without a helmet
- 9. Operate ATV permitting passenger
- 10. Fail to obey direction of a Police Officer.

## TAX COLLECTION

As of June  $13^{\text{th}}$ , 2006 the town's collection rate for 2006 stands at 77.33%. Compared with the same time last year, the town's collection rate is up from 76.53% - that almost a one per cent increase! The town is still owed \$57,122.47 in current and arrears taxes.
