MUNICIPAL ELECTION YEAR

Council elections across Newfoundland and Labrador will be held this September. Any person is qualified to be nominated for a position on council providing they reach the following criteria:

- Is a Canadian Citizen of the full age of 18 years
- Is a resident for a period of six(6) months before nomination day either in the municipality or in an area that on election day is part of the municipality
- Is not in arrears of taxes or other charges payable to the municipality.

This would be a great opportunity to give back to your community. Please think about putting your name on a ballot!!

HYDRANT FLUSHING

The Reidville Volunteer Fire Department will be **flushing the town's fire hydrants** beginning at 9 am on **Sunday, June 14**. Residents are asked to please note this date on their calendar and to be sure and use caution if you happen to be washing laundry on this date.

WRECKS

This year it is very important to have all wrecked vehicles tarped or removed because of the Come Home Year celebration which will bring many people into the town. With this in mind council would like for residents to

make a special effort to keep our town clean from such debris. Council is offering residents an opportunity to register their wrecks with the council office for removal. The fee for removal is \$25 per vehicle, council would be willing to pay \$15(the bulk) and the resident would be responsible for paying the other \$10 (which has to be paid up front).

Anyone with a wreck in their yard has until June 15 to comply with the bylaw listed below. After this date the town will have no choice but to have the vehicle removed at the owner's expense.

Town's Regulations:

"...that any vehicle, not licensable, that does not have four tires and has major external body parts (e.g. fenders, doors) missing shall be considered a wreck and therefore has to be either removed or tarped immediately. Those individuals not complying with the town's by-law will have their wreck vehicle removed at the expense of the owner."

Family, Trees & Museum Display


