# FRIENDLY REMINDER TO HORSE OWNERS

Any rider on a horse is asked to be very conscious of horse droppings on the town's roadways. If you are traveling on the many hay fields in our town, this is not such a concern however while riding on any streets in our town, council would appreciate it if you cleaned up behind your animal. These beautiful creatures are a pleasure to look at and Reidville is the home of many however their droppings can be both a nuisance and a safety hazzard as walkers are forced to walk around it as they travel the town's roadways. Please keep our town, clean, green and happy.

#### **PERMITS**

If you are intending to do ANY construction, council would like to remind residents that building applications MUST be filled out and returned to the office for council approval. Council meets the 2<sup>nd</sup> Monday of every month.

Due to the excessive amount of residents constructing without approval or permit, any resident that continues to construct without a permit or has been ordered to stop work council will proceed with the dismantling of the construction.

## ATV COMPLAINTS

A complaint was put into the council office regarding ATV's going onto residents property. Not only is this considering trespassing, it is destructive to owners land. Many residents take great pride in their property, and to have it destroyed is very unfair to those who have invested time and money to ensure that their land is presentable. Council and residents would appreciate for everyone to keep in mind "Do onto to others as you would have them do onto you".

#### WRECKED VEHICLES

Wishing to remove wrecks from your property. There are a number of businesses in Deer Lake who supply

this service. Please contact either at your convenience. **NOTE:** The town's regulations are printed below for your convenience. Please ensure that any vehicles you have on your property complies with the town's regulations. "...that any vehicle, not licensable, that does not have four tires and has major external body parts (e.g. fenders, doors) missing shall be considered a wreck and therefore has to be either removed or tarped immediately. Those individuals not complying with the town's by-law will have their wreck vehicle removed at the expense of the owner."

#### **BACK TO SCHOOL**

It's back to school time and safety has to be the top item on the timetable. Drivers are asked to be extra cautious and parents are asked to remind their children (including their teens) to please stand on the side of the road off the pavement while waiting for the school bus.

#### TAX COLLECTION

As of August 9, 2007, the town's collection rate for 2007 stands at 97.47%. Compared with the same time last year, the town's collection rate is down from 97.91%.
