PERMITS

Council would like to advise residents that permits are required for new construction as well as general repairs. Any new construction requires approval from council, which could take up to one month

The costs of all Permits are the following:

Commercial (per bldg)	\$200.00
New House:	\$100.00
House Extension:	\$50.00
Accessary Buildings:	\$25.00
General Repairs:	\$10.00

There is No Charge for a General Repairs permit for Seniors. **Please Note:** All taxes for prior years must be paid in full before a permit will be issued.

TAX COLLECTION

As of Friday October 3rd, 2008 the town's collection rate for the current year (2008) stands at 92.83% Compared with the same time last year, the town's collection rate is up from 90.58%.

Council would like to sincerely thank residents who have been diligent with the payment of their account.

To those residents in arrears and not honoring agreements, please note that plans are underway to proceed with further action. The town is in the process of auctioning off arrears accounts again to ensure that collections remain up to date. Also water disconnection notices will be delivered in the coming weeks.


ELECTIONS CANADA, OCTOBER 14, 2008

The Federal Election will be held on Tuesday, October 14, 2008. The polling

station will be set up at the town office from 8:00 a.m. to 8:00 p.m. Don't forget to vote. Council would like to advise residents of the new identification rules for voting this year. When you vote you must prove your identity and address regardless if the people working for elections Canada knows your identity. You have three options: Provide one original piece of identification issued by a government e.g. driver's licence, or provide two original pieces of identification authorized by the Chief Electoral Officer of Canada e.g. health card, hydro bill, or swear an oath and be vouched for by an elector who is on the list of electors in the same polling division and who has an acceptable piece of identification.
