TAX COLLECTION

As of October 20 the town's collection rate for 2014 stands at 97.72%. Compared with the same time last year, the town's collection rate is up from 96.61%.

Council would like to sincerely thank residents who have been diligent with the payment of their account. The water shutoff's that were supposed to be done last Friday had to be put off due to scheduling issues. **Please be aware**: If you received a water shutoff notice the shutoff will occur on Friday, October 24 @ 2 p.m.

NOTE: All seniors (65 years of age or older - or turning 65 any time during 2014) are eligible for an additional 5% discount. Please advise the office if you will reach the age of 65 during the 2014 year so that your taxes can be adjusted to reflect the discount on your 2014 tax bill.
