# TOWN RECEIVES AWARDS AT NLFM CONVENTION

The town of Reidville was recently recognized with one of the Newfoundland and Labrador Federation of Municipalities most prestigious awards at the annual convention held in Corner Brook. The town received the "Torngat Municipal Achievement Award" under the category of "Innovation and Regional Cooperation". In this category, Reidville was chosen over St. Anthony and Grand Falls-Windsor.

The Torngat Award in this category is given to the town that has taken the initiative and focused on "regionalization of services". Government is constantly reminding towns of the benefits of this cooperative venture. With the town's "Regional Animal Control Service" other towns and regions in the province have been trying to duplicate what Reidville has done.

Since the inception of the project in 2000, the town has serviced up to 17 towns. The service is operates on a monthly "confidential" schedule to ensure that the individual doing the service is still available for town needs at least two days per week.

**Tidy Towns:** The town of Reidville also received the "Tidiness Effort Criteria Award" recognizing tidiness, natural beauty and community involvement and also received special recognition for "Friendliness and Hospitality". In our population category, the town of Heart's Content was the winner - hopefully next year we will also be successful in this category!

Long Term Service Awards: Two members of council were also recognized at the same convention for their time in office. Recognized with the Municipal Service Award for 16 years of service was Mayor Louie MacDonald. Recognized with the Municipal Service Award for 12 years of service was Mary Reid. These awards are being forwarded to the town for presentation at a Community function.

#### TAX COLLECTION

As of November 15th, the town's collection rate for 2005 stands at 91.31%. Compared with the same time last year, the town's collection rate is up from 89.64%.

Council would like to sincerely thank residents who have been diligent with the payment of their account and to those in arrears, would like to remind them that notices are being drafted for further action. The town is currently owed: \$27,225.86 overall for taxes. This breaks down as such: \$18,582.20 for current year for 2005 \$8,643.66 for taxes from 2004 & prior.

The town's goal this year is to hit an overall collection rate for 2005 of 96%. If you have a small balance on your account, please pay it off promptly to ensure your credit rating remains positive.

To those accounts that are constantly reminded to pay their accounts - NOTE: accounts are being forwarded to the collection agency as of Friday, November 18<sup>th</sup>. If you have an agreement with the office on the payment of your account, this will not affect you.
