The town has received funding under the Community Enhancement Employment Program and is seeking 2 to 3 workers (depending on the number of hours a person requires to qualify for EI) to work on the trail system. - These positions pay minimum wage.
- All positions are open to both men and woman.
- Workers can be employed for up to 400 hours.
- Individuals who require more than 400 hours of project employment in order to obtain EI benefits are not eligible to participate.

**TAX COLLECTION**

As of November 10, 2014 the town's collection rate for 2014 stands at 97.12%. Compared with the same time last year, the town's collection rate is up from 96.36%.

NOTE: All seniors (65 years of age or older - or turning 65 any time during 2015) are eligible for an additional 5% discount. **Please advise the office if you will reach the age of 65 during the 2015 year so that your taxes can be adjusted to reflect the discount on your 2015 tax bill.**
