When spring breaks (or if our winter is mild), please refrain from the sod fields altogether to protect the crops. Thank you.

TAX COLLECTION

As of December 10, 2007, the town's collection rate for 2007 stands at 92.29%. Compared with the same time last year, the town's collection rate is down from

94.60% .Counci l would like to sincerely thank residents who have been diligent with the payment of



their account and would like to remind everyone that June 30th was the due date for 2007 taxes. Please note that interest is now being charged to those accounts not paid in full.
