**BUDGET**

There will be a small decrease in the mill rate this year to compensate for some of the Municipal Assessment increases - It will decrease from 5.25% to 5.15%, the water rate remains the same at \$338, poll tax will increase from \$250 to \$300 and business tax minimum will increase from \$200 to \$300 for the 2019 year.
